Academic Year 2021-22 has been conducted partially online in the odd semesters and partly offline for the even semesters due to the continuation of Covid-19 regulations. In odd semester the students were able to connect online the college has conducted the lectures through the medium of GMeet. This was more successful in comparison to the earlier year; the students have become more well versed and optimum results have been possible through online mode.

The teachers had to submit the details of the syllabus completed to the departmental coordinators and monthly review of syllabus is done by Principal along with departmental coordinators. Our college is affiliated to R.T.M.N.U., follows the guidelines laid down by university for internal assessment & evaluation. College conducted all the Courses and all the courses have been provide similar marking criteria which consist of maximum of 100 marks in each subject. Out of which for 80 marks, university conducts external examination, and 20 marks of each subject are based on continuous internal assessment and evaluation.

But in the year 2021-22 due to Covid-19 outbreak, physical classes in the odd semesters have been conducted online and the offline has been initiated in the even semesters. In case of our MBA program, Moodle platform was used for assessment and evaluation. Remaining courses have been conducted in the offline for the even semester.

In addition to this, during the odd semesters we have also conducted online internal examination for our students through Google forms which consist of Multiple-Choice Questions & with 20 marks for each subject. Once the offline mode was initiated during the even semesters, the total academic activities for Teaching Learning and Evaluation was totally descriptive and face to face. The grading and marks assessment of the students has been done by following the affiliation university norms.

2.5 - Evaluation Process and Reforms

2.5.1 - Mechanism of internal assessment is transparent and robust in terms of frequency and mode. Write description within 200 words.

In odd semester, as per norms prescribed by university due to covid, google form was created comprising of 20 questions for internal assessment. The students were communicated about the timetable for internal assessment. In even semester physical examinations, class attendance and assignments were used for internal assessments.

All course co-ordinators and the committee members of Internal examination along with principal discussed the norms which are laid by the university and accordingly policy were framed for internal assessment. Once the policy is framed, students were communicated regarding criteria of Internal Evaluation and as per the direction of the university internal assessment marks are provided to the students.

Internal Assessment for Project work and SIP is done by Internal Examiner and External Examiner through the process lay down by the university. Students are informed to prepare ppt and explain work carried on by them. The college is providing the education exclusively for Commerce stream from the year 1940 and in Management Stream from 1987. Its campus is spread in 14.5 acre of Land, on which building construction is 26,709 sq.mt + 1,757 sq.mt (MBA Building). College has adequate physical and academic facilities as per the norms of University Grant Commission, All India Council for Technical Education and R.T.M Nagpur University. The College has 27 well furnished class rooms out of which 15 ICT enabled classroom.

During the pandemic digital resources were used for online teaching-learning and evaluation. Digital room is equipped with recording facilities and are also used to carry out a wide range of online activities through Google Meet/Zoom platform. Collge has installed 34 CCTV camera in college premises for effective surveillance The College has a facility Residential facilities for Staff andHostel for Student.
