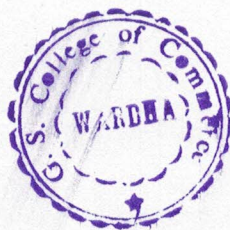

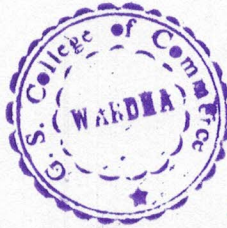
Dr. Sahebrao Chavan Presided the chair. Following decisions were taken after discussion
